Coalition Hails Governor Newsom's Signing of AB 825

AB 825 Will Make California's Electricity More Affordable and Reliable

Sacramento, CA — The unprecedented coalition of business, labor, ratepayers, environmental groups, clean power advocates, CCAs and public utilities backing California participation in an expanded regional power market hailed the Legislature's overwhelming, bipartisan passage of AB 825 (Petrie-Norris, Rivas and Becker).

"We want to thank Governor Newsom, Speaker Rivas, pro Tem McGuire, Assemblymember Petrie-Norris and Senators Becker and Stern for their tremendous leadership in crafting and passing this landmark legislation after prior efforts had failed" said representatives of the bill's sponsors: *Katelyn Roedener Sutter – California State Director at EDF, Victoria Rome – Senior Director of California Government Affairs at NRDC, and Hunter Stern – California State Association of Electrical Workers and the Coalition of California Utility Employees.* "This bill will help lower electricity bills, strengthen our electric grid and expand our access to affordable clean energy."

Independent research has shown that a broad West-wide electricity market like that facilitated by AB 825 will reduce energy costs by more than \$1 billion / year, improve grid reliability and reduce power outages and blackouts, and increase access to affordable clean energy. Recent polling by David Binder Research showed 80% of California voters support legislation like AB 825, with even stronger support for its affordability and reliability impacts.

AB 825 enables implementation of the Pathways Initiative, a proposal developed over the last two years by stakeholder groups from around the Western US with the goal of creating a new entity with independent governance capable of offering an expansive suite of West-wide, voluntary wholesale electricity market functions across the largest possible footprint.

The bill's authors weighed in:

"This proposal is a smart, forward-looking plan to deliver Californians more affordable, reliable, and clean energy. By joining a broader regional energy market, we can cut energy costs by over a billion dollars each year and fortify our grid against climate-driven disruptions. AB 825 is the result of years of hard work and negotiations, and I am confident that the proposal passed today will protect California's energy independence while opening the door to new opportunities to build and share renewable power across the West."
